A RESOLUTION ADOPTING THE FINAL CERTIFIED TAX RATE FOR TOWN OF BLUFF FOR THE FISCAL YEAR 2027 / TAX YEAR 2026

WHEREAS, the Town of Bluff (the “Town”) is an incorporated municipality within the State of Utah and is required to adhere to the Utah Uniform Fiscal Procedures Act for Utah Towns; and

WHEREAS, pursuant to Utah Code 59-2-919, on or before June 22 of each year, the Town shall set the property tax levy for town purposes; and

WHEREAS, the Bluff Town Council has decided to not move forward with the Truth-in-Taxation process for Fiscal Year 2026-2027.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Town Council of Bluff, Utah that:

SECTION 1. Certified Tax Rate. The attached Utah State Tax Commission Form PT-800 is approved, reflecting a Bluff Town Tax of 0.000531. The Final Budgeted Revenue for Tax Year 2026 to be collected is calculated to be \$33,809. The tax rate is hereby adopted.

SECTION 2. Filing with State Auditor. The Town Recorder and Accountant is directed to file a copy of the final budget for each fund with the Utah State Auditor within 30 days of this date.


SECTION 3. Effective Date. This Resolution shall take effect immediately upon adoption.

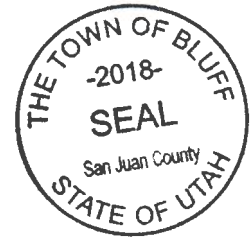
