THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF BLUFF, UTAH:


SECTION 1. Appointment of Lois Young to the San Juan Public Health Board.


The Bluff Town Council appoints Lois Young to fill the town of Bluff's position on the San Juan Public Health Board.

SECTION 2. Effective Date. This Resolution shall become effective upon passage.

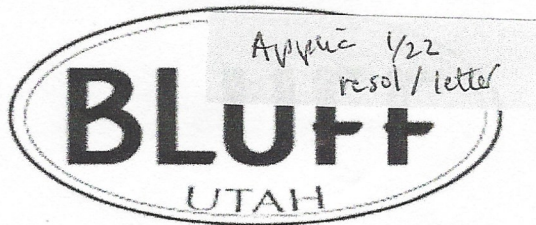
