

RESOLUTION #89

A RESOLUTION OF THE BLUFF TOWN COUNCIL OF BLUFF, UTAH, ADOPTING A TENTATIVE BUDGET; MAKING APPROPRIATIONS FOR THE SUPPORT OF THE TOWN OF BLUFF FOR THE FISCAL YEAR COMMENCING JULY 1, 2025 AND ENDING JUNE 30, 2026.

WHEREAS, the Town of Bluff Budget Officer, as required by law, submitted to the Bluff Town Council a proposed budget (herein the “Tentative Budget”) for the fiscal year commencing July 1, 2025, and ending June 30, 2026; and

WHEREAS, the Bluff Town Council has reviewed and considered the Tentative Budget; and

WHEREAS, it is the intent and desire of the Town of Bluff to comply with all applicable State and local laws regarding the adoption of the Tentative Budget; and

WHEREAS, the Bluff Town Council finds that it is in the best interest of the citizens of Bluff to adopt a Tentative Budget for Town of Bluff.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BLUFF, UTAH:

SECTION 1. Tentative Budget Adoption. The amounts shown in Exhibit “A”, which is attached hereto and incorporated herein by reference, are hereby tentatively appropriated for the corporate purposes and objectives of the Town of Bluff for the fiscal year commencing July 1, 2025, and ending June 30, 2026, and are hereby adopted as the Tentative Budget of the Town of Bluff for the fiscal year 2025-2026.

SECTION 2. Further Action. In addition to the foregoing, the Budget Officer is hereby directed to implement any other necessary actions pertinent to the adoption of the Budget. Such actions may include, but are not necessarily limited to, notification, reporting, and publishing as required by and consistent with applicable law.

SECTION 3. Effective Date. This Resolution shall become effective immediately upon passage.
