



Town of Bluff Annual Conflict of Interest Disclosure Form

The following disclosures are required to be made annually by all officers of the Town of Bluff, pursuant to Utah Code Annotated 17-16a-6, 7, and 8. If additional space is needed, please use a separate sheet of paper. Per statute, the information provided shall be kept on file with the Town Recorder and may be subject to disclosure to the public.

I, Jennifer Davila am the duly elected/appointed Town Council of the Town of Bluff.

- 1) I am an officer, director, agent, employee or owner of a substantial interest in the following business entities which are subject to the regulation of Town of Bluff, and within such business entities, I hold the following positions:

Ownership of a substantial interest is defined in U.C.A. 17-16a-3(8) as an interest of 10% or more of the shares of a corporation, or a 10% or more ownership interest in other entities, legally or equitably held or owned by the officer, the officer's spouse, or the officer's children.

*Note: There is no case law or statutory guidance as to what constitutes a business entity "subject to regulation of the Town." A business which is simply issued a business license by the Town may or may not be deemed by a court, administrative agency, an auditor, or member of the public to be an entity regulated by the Town. Businesses regulated by interlocal agencies of which the Town is a member may or may not be deemed to be a business regulated by the Town (i.e., a restaurant subject to regulations imposed by an interlocal agency). A business entity which requires a conditional use permit to operate may more likely be deemed to be a business entity regulated by the Town of Bluff than a business that simply receives a business license from the Town.

- 2) I am an officer, director, agent, employee or owner of a substantial interest in the following business entities which do business with or anticipate doing business with Town of Bluff: Business Entity Name / Position within Business Entity:
